**Attendance:** Planning Board Members Peter Fox, Frank O'Connor John Heidke, Dave Haug, Frank Schroeder; Planning Staff, Mike Inman; Public, (see sign in sheet 55+ people)

**Call to Order and Introductions:** 5:30pm, Peter Fox called the meeting to order.

**Conflict of Interest:** Schroeder mentioned he lived in the Paradise Valley outside of the proposed zoning district. Heidke mentioned he lived within the boundaries of the proposed zoning district.

**Review and Approval of Minutes from Previous Meeting:** Schroeder pointed out a typo to be corrected. *O'Connor made a motion to approve the minutes as submitted, Haug seconded, motion passed unanimously.*

### **Discussion of Community Decay Ordinance Presentation from Gallatin County**

**Enforcement Officer:** Inman gave a recap of the Enforcement Officers presentation and added that it was encouraging to hear the amount of time allotted to Community Decay was not as much as originally assumed. Fox informed the public that the Board's primary interest in researching the ordinance was to address the most egregious situations in the County and gave the Board's history of researching a Decay Ordinance. The Board and staff discussed the applicability of the presentation to potential enforcement in Park County.

*O'Connor made a motion to direct Staff to develop a Community Decay Ordinance Draft, Schroeder seconded, motion passed unanimously.*
