

## GREETING AND ADVISEMENT OF RIGHTS

THIS IS JUSTICE COURT AND I AM LINDA BUDESKI, JUSTICE OF THE PEACE. THIS IS A TIME SET ASIDE FOR PEOPLE TO APPEAR ON CITATIONS AND COMPLAINTS. YOU ARE ADVISED OF YOUR RIGHTS AS A GROUP. THEN EACH OF YOU WILL BE ASKED TO APPROACH THE BENCH TO ANSWER YOUR PARTICULAR CHARGES. \_\_\_\_\_ IS CLERK IN THIS COURT AND WILL HANDLE ANY PAPERWORK GENERATED THROUGH THE ENTRY OF PLEAS.

YOU HAVE THE RIGHT TO REMAIN SILENT AND ANYTHING YOU SAY CAN AND WILL BE USED AGAINST YOU IN A COURT OF LAW. You have the right not to be compelled to offer evidence that may incriminate you.

YOU HAVE THE RIGHT TO CONSULT WITH AN ATTORNEY AND TO HAVE ONE PRESENT WITH YOU AT THIS QUESTIONING. SHOULD YOU NOT BE ABLE TO AFFORD AN ATTORNEY, IF YOU QUALIFY AND UNDER CERTAIN CIRCUMSTANCES ONE WILL BE APPOINTED BY THE COURT.

YOU CAN EXERCISE THESE RIGHTS AT ANY TIME BY REFUSING TO MAKE STATEMENTS OR ANSWER QUESTIONS.

UPON THE ENTRY OF A NOT GUILTY PLEA YOU HAVE THE RIGHT TO A TRIAL BY JUDGE OR BY JURY AND AT EITHER TRIAL YOU HAVE THE RIGHT TO HAVE WITNESSES SUBPOENED TO TESTIFY FOR YOU AND THE RIGHT TO CONFRONT AND QUESTION ANYONE WHO MAY TESTIFY AGAINST YOU.

YOU HAVE THE RIGHT TO HAVE THE STATE PROVE THE CHARGE BEYOND A REASONABLE DOUBT.

IF YOU ARE NOT A CITIZEN OF THE UNITED STATES, UPON THE ENTRY OF GUILTY PLEA OR FINDING OF GUILT YOU COULD BE DEPORTED.

YOU MAY BE REQUIRED TO PAY RESTITUTION, COURT COSTS OR ASSESMENTS IF YOU ARE CONVICTED OR PLEAD GUILTY. The court retains jurisdiction until restitution is paid in full.

UPON THE ENTRY OF A GUILTY PLEA YOU WAIVE YOUR RIGHT TO AN APPEAL.

ON THE MORE SERIOUS CHARGES YOU HAVE THE RIGHT TO HAVING BOND SET AND UPON POSTING BOND BEING RELEASED PENDING THE DAY AND DATE OF YOUR TRIAL.

### FELONY ONLY

You have the right to a hearing on probable cause on any felony charge. This charge must fully be disposed in District Court.

If You are convicted or plead guilty you could lose your civil rights or the right to own a weapon for the rest of your life.
