The Board of Trustees of Cooke City School District 9 met in regular session on **September 17**, **2025** at the school.

The Clerk and Superintendent were present via phone and video call throughout the entire proceedings.

Chairman Marie Carpenter called the meeting to order at 5:04 p.m.

Business

A motion was made (MC) and seconded (AH) to approve the minutes of the 8/13/25 board meeting. No comments. Motion passed with all in favor.

A motion was made (MC) and seconded (AH) to approve the claims and ACH payments as presented. No comments. Motion passed with all in favor.

A motion was made (MC) and seconded (AH) to have the septic tanks at the school and teacherage pumped using resort tax funds. Comment was made regarding splitting the truck cost with another person or business, Lara said that the two tanks would take a full truck, no further discussion. Motion passed with all in favor.

Lara said the playground needs some repairs and she has had someone out to look at the work. A motion was made (MC) and seconded (AH) to approve the playground repairs using resort tax funds for materials and fair compensation for labor. No further discussion, motion passed with all in favor.

There are no more requests at this time for purchases using resort tax funds.

The Clerk informed the Board about Bridged Health Alliance and asked if the school would like to request a proposal. The Board asked Lara and she happy with the current arrangement.

The Board and Lara discussed if anything more can be done at this time to help with future student enrollment. Lara is beginning to work on her thesis which looks at the shortage of affordable housing in Cooke City and what measures can be taken to improve the situation. It was agreed that nothing actionable can be done at this time.
