**LIVINGSTON HIGH SCHOOL DISTRICT
TECHNOLOGY LEVY PROPOSITION
(VOTE IN ONE OVAL)**

Shall the district be authorized to levy an additional 2.75 mills per year for 10 years and being approximately \$185,000 DOLLARS (one hundred eighty five thousand) in fiscal year 2025 for the purpose of purchasing, renting, repairing and maintaining technological equipment, including computers and computer network access, cloud computing services for technology infrastructure, platform, software, network, storage, security, data, database, test environment curriculum, or desktop virtualization purposes, including any subscription or any license-based or pay-per-use service that is accessed over the internet or other remote network to meet the district's information technology and other needs, and the associated technical training for school district personnel.

Passage of this proposal will increase the annual taxes on a home with a market value of \$100,000 by approximately \$3.63 per year, on a home with a market value of \$300,000 by approximately \$10.89 per year, and on a home with a market value of \$600,000 by approximately \$21.78 per year. An increase in property taxes may lead to an increase in rental costs. This request is in addition to \$100,000 DOLLARS previously authorized as a perpetual levy and, if this proposition is approved, will hereby be limited to 10 years.

**ARROWHEAD ELEMENTARY
GENERAL FUND PROPOSITION
(VOTE IN ONE OVAL)**

Shall the district be authorized to impose an increase in local taxes to support the general fund in the amount of \$18,295.58 which is approximately 1.00 mills for the purpose of general operation and maintenance of the District?

Passage of this proposal will increase the taxes on a home with a market value of \$100,000 by approximately \$1.35 and on a home with a market value of \$300,000 by approximately \$4.05 and on a home with a market value of \$600,000 by approximately \$8.10. An increase in property taxes may lead to an increase in rental costs.

The durational limit of the levy is permanent once approved by the voters, assuming the district levies that amount each year thereafter. However, lowering over-BASE tax levies in any year will lower the amount of permissively over-BASE levies in subsequent years.
