Shall the board of trustees be authorized to impose an increase in local taxes to support the general fund in the amount of Fourteen Thousand Nine Hundred Forty Five Dollars and Thirty Six Cents (\$14,945.36) per year which is approximately 1.41 mills, for the purpose of: Financing general maintenance and operation costs of the Shields Valley Elementary School District Programs.

Passage of this proposal will increase the taxes on a home with a market value of \$100,000 by approximately \$1.90, on a home of a market value of \$300,000 by approximately \$5.71, and on a home with a market value of \$600,000 by approximately \$11.42.

The durational limit of the levy is permanent once approved by the voters, assuming the district levies that amount at least once in the next five years.
