We the undersigned Road Viewers of that portion of Cinnabar Basin Road and Old Yellowstone Trail subject to Road Abandonment Petition # 162, submitted in the office of the Clerk and Recorder of Park County, Montana on December 10th, 2021 respectfully submit the following report:

ROAD VIEWERS REPORT

On Monday December 20th, 2021, Park County Commissioner Bill Berg and I (George Bornemann) viewed that portion of Cinnabar Basin Road and Old Yellowstone Trail subject to said petition. In or around 2006, the Montana Department of Transportation (MDOT) acquired additional right-of-way from the United States Department of Agriculture, National Forest Service (NFS), on behalf of Park County, to realign Cinnabar Basin Road and Old Yellowstone Trail so that they would align with the new Corwin Springs Bridge which was being replaced.

The realignment also improved the intersection and safety of the two roads as they lined up with the newly constructed bridge. As part of the letter of consent with the NFS, it was agreed that any right-of-way that was no longer needed for the realigned roadways would be quit-claimed to the NFS.

The portions of right-of-way shown as shaded on the attached exhibit prepared by MDT, lie outside of the newly acquired expanded right-of-way and are no longer needed by Park County for road maintenance.

We, the undersigned road viewers, would recommend that the Park County Commission resolve to abandon the areas shown on the MDT exhibit for the following reasons:

- 1. The new right-of-way width in the re-aligned areas varies in width from 40 46 meters wide (approximately 130' 150') more than twice the width of the original 60' wide right-of-way.
- 2. The petitioned areas are no longer necessary for roadway use or maintenance and some portions have been re-graded to match surrounding ground.
- 3. Abandonment of the subject areas was previously agreed to in Letter of Consent with National Forest Service, as stated in petition.


