DONALD FRASER FAMILY HISTORY COLLECTION HISTORICAL NOTE

John Fraser Sr. arrived in the Montana Territory with his wife's cousin, Hugh McMillan in 1874. Hugh contacted his brother Donald McMillan who brought them to Bozeman where they were hired as carpenters by Major Pease. In the spring of 1875 all three were employed to move the Crow Agency from Fort Parker to a location on the Stillwater River near the present town of Absarokee. In 1876 they were working for a lumber mill on Mill Creek that had been built by John Tomlinson and sold to Major Pease. In the spring of 1877 they floated a raft of saved lumber, which they sold to a post trader in Milestown. They bought a building on main street and opened the first blacksmith and wagon repair shop.

John Fraser purchased land on the east side of Miles City. He returned to Canada to bring his family, his wife and six children to Miles City. Most of the children relocated to Livingston except for his daughter who married the Northern Pacific road master Daniel McPhearson.

John Fraser, Jr initially worked at a bartender at the Albemarle Hotel and then at the I Roth Saloon. In 1898 he joined the Livingston Police Force. In 1915 he left the force when he was elected the Park County Assessor. In 1935 he was also elected as Justice of the Peace. He held both positions until his death in 1942.

Hugh Fraser was employed as the head bartender at the Bucket of Blood Saloon. Later he married and moved to a farm in the Miles City area. Archibald Fraser worked as a switchman for the Northern Pacific in Livingston. He was promoted to yard master and continued working for the railroad until he retired in 1925.

John Angus Fraser worked as a cook for the Harvat Sheep Company and then fought in the Spanish American War. Afterwards he relocated to Denver, Colorado where he spent the rest of his life. Danial Fraser moved to Livingston and began a partnership with Frank Aulspaul to open the Progress Mens Store. He later went into another men's clothing business with Charles Landis until his death.

John Fraser, Sr. remained in the family home in Miles City with his wife until 1901 when the relocated to Livingston to be near their children. He purchased 10 acres which he eventually developed into an orchard. His wife died in 1904, John Sr. turned the farm over to John Jr. and lived with his family until his death in 1917.

James Fraser remained in Miles City with his sister. He worked as a blacksmith at Fort Keogh for several years and later for the Milwaukee Railroad. In 1915 he joined the Miles City police department. He worked for the police department until he was killed in action in 1935.

Donald Fraser was born on May 6, 1916 in Three Forks, Montana. The same year his family moved to Livingston, MT. They later moved to Mammoth Springs in Yellowstone National Park. They returned to Livingston in 1927. Don Fraser attended the University of Montana. While enrolled he worked at night for the Union Pacific Hospital in Missoula. In 1938 Don began working full-time for the Northern Pacific Railway. He worked for the railroad company until 1940 when he purchased the Town Pump Texaco Service Station in Livingston. In 1942 he entered the U.S. Army and also married Olga J. Garvey. After his discharge from the Army he continued on in the Air Force Reserve for 30 years.

Don took a job with the Livingston Police Department, where he worked for 22 years. He retired in 1968. After his retirement he worked for the Yellowstone National Park for eight years as a law enforcement officer. Don was extremely active in many fraternal and civic organizations including serving as a Boy Scout leader, and as a member of Livingston Masonic Lodge, Livingston Scottish Rite Bodies, Livingston Elks Lodge, Algeria Shrine Temple in Helena, American Legion, VFW, Yellowstone Gateway Museum, Park County Pioneer Society and Senior Citizens of Park County in which he served two terms as president.

Don and Olga Fraser had one daughter, Dianne. Donald Fraser died in 2005.

DONALD FRASER FAMILY HISTORY COLLECTION SCOPE AND CONTENT NOTE

The material in the collection dates from 1871-1999. The collection comprises of pages from two scrapbooks Don Fraser created on the family that document his family history. A portion of another scrapbook documents his donations to various museums, primarily in Montana. The scrapbooks were disassembled to preserve the historical material but the original order was maintained. The container list includes the original scrapbook page number. The scrapbooks contain family histories written by Don Fraser, original documents such as letters, clippings, certificates, deeds, memorials, articles, family genealogy and biographies. The collection also contains small objects such as badges and ties along with family photographs. The objects and photographs remain in the collection to preserve the original organization of the scrapbooks. Three oversized items, including two certificates were relocated to a map case for proper preservation.

Related material includes two large scrapbooks created by Don Fraser, 2001.015.0020 (1916-1980); and 2001.015.0021 (1980-2001) of his life, family, work. Pdf of pages available in PastPerfect at the museum.
